ACCIDENT WAIVER AND RELEASE OF LIABILITY

I hereby release the National Basketball Retired Players Association ("NBRPA"), NBRPA Marketing, Inc., the National Basketball Association, Inc., the National Association of Police Athletic/Activities Leagues, Inc., Leadership Foundations, NBA, Jr. NBA, their respective officers, directors, employees, members, the Clinic organizers, coaches, other players and volunteers from any and all claims, demand rights or clauses, present or future, whether known, anticipated, or unanticipated, resulting from or arising out of, or incident to, in whole or in part, my participation in the Clinic and related activities, whether or not caused by negligence of the parties released hereby.

In further consideration for being permitted to participate in any way in the event, I, for myself, my representatives, assigns, successors, and heirs represent and agree as follows:

I acknowledge that this event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by facilities, court conditions, temperature, weather, condition of athletes, equipment, actions of other people including, but not limited to, participants, coaches, volunteers, spectators, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the



part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person.

I further acknowledge that the Clinic will be conducted at Middle School North -at 501 Squankum Yellowbrook Rd. Farmingdale, NJ 07727 . If at any time I believe conditions to be unsafe I will immediately discontinue further participation in the activity.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the NBRPA, event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration for my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, the following entities or persons: the National Basketball Retired Players Association ("NBRPA"), NBRPA Marketing, Inc., the National Basketball Association, Inc., the National Association of Police Athletic/Activities Leagues, Inc., Leadership Foundations, NBA, Jr. NBA, their directors, officers, employees, volunteers, representatives, and agents, the event holders, event sponsors, event directors, event volunteers; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my actions during this event.

I hereby consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and or illness during this event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, partner agencies, producers, sponsors, organizers and or assigns.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I hereby certify that I have read this document; and, I understand its content. I understand that I have given up substantial rights by signing this AWRL and have signed it freely and without any inducement or assurance of any nature.
